Collection of your Personal Information

South San Francisco Conference Center collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number.

There is also information about your computer hardware and software that is automatically collected by the South San Francisco Conference Center website. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by the South San Francisco Conference Center for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the South San Francisco Conference Center website.

South San Francisco Conference Center encourages you to review the privacy statements of websites you choose to link to from South San Francisco Conference Center so that you can understand how those websites collect, use and share your information. The South San Francisco Conference Center is not responsible for the privacy statements or other content on websites outside of the South San Francisco Conference Center website and the South San Francisco Conference Center family of websites.

Use of your Personal Information

South San Francisco Conference Center collects and uses your personal information to operate South San Francisco Conference Center website and deliver the services you have requested. South San Francisco Conference Center also uses your personally identifiable information to inform you of other services available from South San Francisco Conference Center. South San Francisco Conference Center may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

South San Francisco Conference Center does not sell, rent or lease its user lists to third parties.

South San Francisco Conference Center keeps track of the websites and pages our clients visit within South San Francisco Conference Center website, in order to determine what services are the most popular.

South San Francisco Conference Center website will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal

Use of Cookies

South San Francisco Conference Center website uses "cookies" to help personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, a cookie helps South San Francisco Conference Center website to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same website, the information you previously provided can be retrieved, so you can easily use South San Francisco Conference Center website features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of South San Francisco Conference Center services or websites you visit.

Security of your Personal Information

South San Francisco Conference Center website uses industry standard security to secure your personal information from unauthorized access, use or disclosure, and has taken reasonable precautions to protect such information from loss, misuse, or alteration.
